## QUARTERLY HIGHLIGHTS

The Matrix ESG Dividend Income strategy (ESG-DI) posted another solid quarter, up +3.13%, net of fees versus +3.81% for the Russell 1000 Value® Index. For the full year, ESG-DI was up +16.06% net of fees, modestly ahead of the Russell 1000 Value® Index's +15.91% return. The strategy is also ahead of the benchmark since inception on 6/30/2021. Notably, the portfolio achieved these healthy gains with less volatility than the overall market.

In a very volatile year for the stock market that ranged from being down -14.99% at its low on April 8 to up +17.88% on December 31, 2025, the ESG-DI portfolio showed positive performance in every quarter in 2025, delivering on all three of its objectives: generating high current and growing income, providing downside protection in difficult markets, and capital appreciation over time.

The strong operating performance of the portfolio's holdings in 2025 allowed them to further increase their dividends to shareholders. During the fourth quarter, three portfolio holdings increased their dividends. All holdings increased their dividends in 2025 by an average of mid-single digits.

As of December 31, the portfolio yielded 2.84%, which compares favorably with the 1.14% yield on the S&P 500® and the 1.86% yield on the Russell 1000 Value®. It had an average P/E multiple of 15.5x on estimated 1-year forward earnings, compared to 17.4x for the Russell 1000 Value® Index and 22.0x for the S&P 500.

We believe the ESG Dividend Income portfolio is well positioned for the market outlook we foresee. Lower short-term money market rates following any additional Fed Fund cuts should renew the market's interest in dividend paying stocks, providing an additional tailwind for the portfolio.

**The Matrix ESG Dividend Income Composite** contains fully discretionary dividend income equity accounts that invest in high-quality U.S. large cap value companies that pay high dividends consistently and have raised their dividends historically. For comparison purposes the composite is measured against the S&P 500® Index and Russell 1000® Value Index. The S&P 500® Index is an index that measures the performance of 500 publicly traded companies, which are among the largest in the United States. As of January 2018, it is also measured against the Russell 1000® Value Index, an index which measures the performance of the companies in the Russell 1000® Index with lower price-to-book ratios and lower forecasted growth values. The Russell 1000® Value Index was added as a benchmark as it reflects the investment style of the strategy. The minimum account size for this composite is \$100,000.

Matrix Asset Advisors, Inc. claims compliance with the Global Investment Performance Standards (GIPS®) and has prepared and presented this report in compliance with the GIPS standards. Matrix Asset Advisors, Inc. has been independently verified for the periods 1/1/92 through 12/31/21. Verification assesses whether (1) the firm has complied with all the composite construction requirements of the GIPS standards on a firm-wide basis and (2) the firm's policies and procedures are designed to calculate and present performance in compliance with the GIPS standards. The Dividend Income Composite has been examined for the periods January 1, 2011 through December 31, 2021. The verification and performance examination reports are available upon request. Matrix Asset Advisors, Inc. is a registered investment adviser that manages equity and fixed income assets for client accounts. The firm's list of composite descriptions is available upon request.

Results are based on fully discretionary accounts under management. Since inception, the composite policy requires the temporary removal of any portfolio incurring a client initiated significant cash inflow or outflow of 15% or greater of portfolio assets. Net of fee performance was calculated using the highest management fee of 0.65%, as per our fee schedule and applied quarterly. The annual composite dispersion presented is an asset-weighted standard deviation calculated for the accounts in the composite the entire year. Additional information regarding the policies for valuing portfolios, calculating performance, and preparing compliant presentations are available upon request. The management fee schedule is as follows: 0.65% on the first \$5,000,000 of assets under management, 0.55% on the next \$5,000,000 of assets under management, 0.50% on the next \$15,000,000 of assets under management, 0.45% on the next \$25,000,000 of assets under management, 0.35% on the next \$50,000,000 of assets under management and 0.30% on assets under management in excess of \$100,000,000. Dividend Yield is a financial ratio that tells you the percentage of a company's share price that it pays out in dividends each year.

Annualized Returns - an annualized rate of return is calculated as the equivalent annual return an investor receives over a given period. The Global Investment Performance Standards dictate that returns of portfolios or composites for periods of less than one year may not be annualized. This prevents "projected" performance in the remainder of the year from occurring.

Market Capitalization Weighted is average market capitalization is a type of market index in which each component is weighted according to the size of its total market capitalization. Market capitalization is the sum of the total value of a company's outstanding shares multiplied by the price of one share.

VMY Vanguard High Dividend Yield ETF seeks to track the performance of the FTSE® High Dividend Yield Index, which measures the investment return of common stocks of companies characterized by high dividend yields.
